**Entry Limits:**

- You may enter 1-4 debaters of your choice to the **State Championship** level. Debaters must have participated in AT LEAST one ICDA invitational tournament – 2019-2020 season.
- You may enter 1-10 debaters in the invitational tournament.

**Entry Fees:**

Championship Level (1-2 debaters) = \$50/team  
(3-4 debaters) = \$100/team

Invitational Level - \$11/debater

Dear Congressional Debate Coach,

On behalf of the Illinois Congressional Debate Association, I invite you to the 2020 ICDA State Tournament. It is now time to complete your entry. On the ICDA website you will find this [REGISTRATION PACKET](#), along with the [Championship Rules](#) and [Invitational Rules](#). It is important that you read everything carefully, and complete the registration packet (esp. rules acknowledgement form). Submit entries using the Google Forms by the registration deadline.

**Judging assignments:** The rules call for one judge if you enter the Championship level, and one judge if you enter the Invitational level. Head coaches must assign themselves or an assistant coach to the Championship level. Hired judges **will not** be allowed to judge the Championship level. Coaches assigned to the Championship level will be assigned by name, not school. *Only experienced coaches and judges may judge at either level.*
